Labour Commissioner, Jharkhand hereby amend Proviso 13 (i) of the Annexure related to Conditions of Service issued vide order no-1559 Dated-20-06-2011 as follows and direct that it will be effective from the date of notification :-

**13. Wage Rate :-**

- (i) Where no rate of wage have been regulated by way of agreement, settlement or award for such employment applicable for any category or class of workmen the Contractor shall pay following wages :-

Category of Workmen	Wage in Rs. (in Month)
Un-Skilled	8,571.78
Semi-Skilled	8,977.47
Skilled	11,935.06
Highly-Skilled	13,675.59

- (ii) Other Conditions related to rates of wages, holiday, hours of work and conditions of service shall remain same as in the original order.




